

Kellogg Financial Aid Information: Part-Time MBA Program

As a newly admitted student, you may have questions about Kellogg tuition and options for financial aid. New students start the financial aid application process immediately after they have received an offer of admission from Kellogg. The following information may be helpful as you research options for financing your MBA education.

Part-Time MBA students complete a total of 20.5 units to earn an MBA from the Kellogg School. Most classes are 1 unit courses, although 0.5 unit courses are offered on occasion. Students are not charged for the 0.5 unit core course, so they pay for a total of 20 units of classes.

The following tuition fees apply to the Kellogg Part-Time MBA Program:

For the 2013-2014 academic year (starting in Fall 2013)

1-Unit Course: \$5,739.00

0.5-Unit Course: \$2,870.00

Please note the cost of attendance for the 2013-14 Academic Year is not finalized. Figures will be updated as soon as they are available. Please check our Welcome Website for Admitted Students in late June.

The following table illustrates the availability and eligibility for various forms of financial aid:

Financial Aid Type	U.S Citizen or Permanent Resident	International Student (VISA)
Federal Stafford Loans	Eligible if you are taking two 1-unit courses per quarter. You can borrow up to \$20,500 each academic year. Students whose employers pay for part of their tuition also may be eligible for loan assistance. If you take fewer than two courses per quarter, you are not eligible for this option.	Not eligible
Federal Graduate PLUS Loan	Eligible if you are taking two 1-unit courses per quarter. Students whose employers pay for part of their tuition also may be eligible for loan assistance. Approval for this loan is based on a credit review performed by the Department of Education. Borrowers with adverse credit history may apply for the loan with a co-signer. If you take fewer than two courses per quarter, you are not eligible for this option.	Not eligible
Private Loans	Eligible if you are taking one or more classes per quarter. Students whose employers pay for part of their tuition also may be eligible for loan assistance.	Eligible if you are taking one or more classes per quarter. Students whose employers pay for part of their tuition also may be eligible for loan assistance. You may be asked to provide a co-signer (who is a U.S. citizen) for a private loan.
Scholarships/Grants	While the Part-Time MBA Program does not offer institutional scholarships or grant aid, there are a variety of scholarship programs available through civic and professional organizations, state agencies and private foundations.
