- What kinds of legislative responses are being discussed that will affect how publicly traded companies are governed?
- Why does corporate governance matter and is there any evidence that good governance creates additional value for shareholders?
- Hedge funds have been cited by some politicians as prime targets for blame and for corporate governance reform. How is that industry responding and what might the future be for the regulation of such funds?
- Where do best practices of corporate governance fit into the education of an MBA student?
